ITEM NO. 1 Meeting Called to Order

The regular meeting of the West Manheim Township Planning Commission was called to order at 6:00 p.m., by Chairman Jim Myers, followed by the Pledge of Allegiance.

ITEM NO. 2 Roll Call

The roll was called, and the following Commission Members were present: Chairman, Jim Myers, Darrell Raubenstine, Jay Weisensale, Andrew Hoffman and Duane Diehl. Also present was Kevin Null, Township Manager and Mike Knouse, C.S. Davidson.

ITEM NO. 3 Approval of Minutes

Andy Hoffman made a motion to approve the minutes from the Planning Commission Re-Organization Meeting of January 19, 2012, seconded by Duane Diehl. *The motion carried.*

ITEM NO. 4 Correspondence

Jim Myers, Chairman reported that no correspondences were received.

ITEM NO. 5 Visitors

Chairman Jim Myers asked if there were any visitors present that wished to address the Commission, and received no reply.

A. Zoning/Hearing Board

Kevin Null, Zoning Officer said the Zoning Hearing Board will meet on Tuesday, February 28, 2012 at 7:00 pm, to hear the request for a Variance from St. David's United Church of Christ.

ITEM NO. 9 Old Business

1. Waiver Requests:

Brian Reisinger, HRG, Inc. was present on behalf of the applicant. He said they would like to go over three of the waiver requests they withdrew last month. He provided updated out hands to the Commission.

A. Homestead Acres – 366 Lot Preliminary Subdivision Plan

1. Cul-de-sac with emergency access

Brian Reisinger, HRG, Inc. said the first waiver was regarding Section 505 (e) of the Subdivision and Land Development Ordinance that cul-de-sacs shall not exceed 500' feet in length unless topographic conditions and/or tract shape warrant an increase that is approved by the Township. He said what they have tried to accomplish is an emergency exit to allow residents to be evacuated out of the cul-de-sac areas in the event of an emergency. This includes a 15 foot wide gravel road as shown on the updated handout provided. After further discussion, the Planning Commission would like to receive additional information from Emergency Services and the Zoning Officer before making a recommendation to the Board of Supervisors.

Darrell Raubenstine made a motion, seconded by Andy Hoffman, to table the waiver request and to not make a recommendation until they receive additional written recommendations and comments from Emergency Services, the Township Engineer and the Zoning Officer. *The motion carried.*

2. 500' intersection distances

Brian Reisinger, HRG, Inc. said the second waiver request is Section 506 (c) of the Subdivision and Land Development Ordinance regarding intersection distances. The Minimum distance between centerlines of intersections of minor streets and minor streets and collectors is 500 feet.

Jeff Stough, J.A. Myers Building & Development provided additional handouts to the Planning Commission regarding information related to the 500 foot intersection distances with other older developments located throughout the Township. He said he would like that they are treated the same way as other people have been treated when coming into the Township. After further discussion, the Planning Commission would like to receive additional information from Emergency Services and the Zoning Officer before making a recommendation to the Board of Supervisors.

Darrell Raubenstine made a motion, seconded by Jay Weisensale, to table the waiver request and to not make a recommendation until they receive additional written recommendations and comments from Emergency Services, the Township Engineer and the Zoning Officer. *The motion carried.*

3. Driveway offsets of 2'0"

Brian Reisinger, HRG, Inc. provided a color photo to the Commission of how the proposed units are going to look including the floor plan. He reviewed the waiver request Section 507 of the Subdivision and Land Development Ordinance regarding the driveway offsets. After further discussion, the Planning Commission would like to receive additional information from Emergency Services and the Zoning Officer before making a recommendation to the Board of Supervisors.

Darrell Raubenstine made a motion, seconded by Duane Diehl, to table the waiver request and to not make a recommendation until they receive additional written recommendations and comments from Emergency Services, Fire Company, the Township Engineer and the Zoning Officer. *The motion carried.*
