Darrell Raubenstine made a favorable recommendation to the Board of Supervisors for the Final Subdivision Plan–Minor Plan, seconded by Duane Diehl. *The motion carried.*

B. St. David's United Church of Christ – 1-Lot Final Plan

Gerald Funke, GHI, Engineers was present to represent the plan on behalf of the applicant. He said they are asking for a favorable recommendation to the Board of Supervisors for approval. They have addressed all of the engineering and York County comments.

Mike Knouse, C.S. Davidson said all of the engineering comments have been addressed. The only remaining outstanding items that are to be addressed are the outside agency approvals. The outside agencies include DEP for the Planning Module and the York County Conservation District.

Chairman Jim Myers said Emergency Services letter dated August 23, 2012 indicates that the access and egress into and out of the parking areas are acceptable.

Darrell Raubenstine made a favorable recommendation to the Board of Supervisors for the Final Subdivision Plan–Minor Plan with the stipulation that the proper signatures are received from the church, and that the outside agency conditions are addressed, seconded by Andy Hoffman. *The motion carried.*
