Supervisor Ault questioned why the bond for the Manager and the Treasurer was so large. Linus informed the board members that the amount of the treasurer's bond should equal the highest amount of the township funds estimated by the Board of Supervisors to be available to the township treasurer at any time during the current year. After discussing the amounts that could be in the accounts at one time, the Board decided to change the amount of the Manager to \$1.5 million and the Treasurer to \$3 million. After the discussion, Supervisor Staaf amended his motion.

Supervisor Staaf amended his first motion to establish the Manager's bond at \$1.5 million dollars and the Treasurer bond at \$3 million dollars, seconded by Supervisor Ault. The motion carried.

Supervisor Ault made a motion to adopt the Fee Schedule for Services and Permits and Sewer Rates Resolution # 2016-01, seconded by Supervisor Staaf. By a unanimous roll call vote the West Manheim Township Board of Supervisor adopted Resolution #2601-01. The motion carried.
