### FALL LIMB PICK UP

West Manheim Township Public Works
Department will be collecting brush and
limbs. All items must be curbside by
Sunday of designated week to guarantee
removal. The west side of the Township
will take place on October 12<sup>th</sup> - 16<sup>th</sup> and
the east side will be October 19<sup>th</sup> - 23<sup>rd</sup>.

Limbs should be no larger than 3 inches in diameter and brush should be stacked for easy pickup. Absolutely no boards, lumber or construction type debris will be accepted.

The Township reserves the right to refuse excessive amounts of debris. The Township can refuse items that do not meet the requirements and is **NOT** responsible for cleanup.

### LEAF COLLECTION

Leaves may be placed curbside for collection starting November 2<sup>nd</sup>. The crews will go through the Township more than once in the event that all leaves are not down and curbside by this date. Leaves must not be in any type of bag or container. Leaf collection is expected to take about 3 - 4 weeks with the last collection day being November 30<sup>th</sup>, dependent upon the weather conditions.



## TAX NEWS

### **Message from Ruth Neiderer, Tax Collector**



Real Estate/Property Taxes are based on your assessed value generated by the York County Assessment Office 717-771-9232. The tax rate is determined by the elected officials of each taxing district.

The tax bill is the property owner's responsibility. All bills are mailed to the property owner. I would encourage you to check lender's statements to be sure payments have been disbursed.

The York County and West Manheim Township bills are mailed mid-Feb. and the 2% discount is due mid-April. The South Western School bill is mailed mid-July and the 2% discount is due by the end of September. There is an option to pay the school bill

in three installments. The first installment payment must be received by August 31st.

If you have an escrow account which pays your real estate taxes, please contact or forward it to them. If you have applied for a permit due to an improvement to your property, an interim bill is generated. INTERIM bills must be forwarded to your lender for payment. All current year bills must be paid in full by December 31st each year. Personal checks are not accepted after December 15th. Payments can be made by mail (post mark is accepted) or placing in the township drop box or stopping by during office hours. Payments: Credit card and cash (over \$100.00) are not accepted. 
### **Ask For Their Peddlers Permit**

West Manheim Township requires a Peddler's or Solicitor's Permit for anyone engaged in door-to-door sales of merchandise, goods and/or services. If approved, the Township will give the applicant a solicitation permit (seen here). Residents should ask peddlers to see their solicitation permit to prove it has been issued. When the Township issues a Solicitation Permit it is not an endorsement of the quality or safety of the product or service. The purpose of the permit is to allow the Police Department to conduct a background check and to have contact information on file if a complaint about an individual or organization is received. If the individual cannot display their permit issued by West Manheim Township, he/she is not authorized to engage in door-to-door sales. Please notify the police of those performing unauthorized soliciting in West Manheim Township.

## WINTER REMINDERS

- Do not drive unless it is absolutely necessary. If a state of emergency is called, please stay off the roads so the plows can do their job without any more danger.
- When possible remove parked cars from roadway to allow the Public Works Department to plow curb to curb.
- Please refrain from completely clearing your driveway until that truck makes its last pass due to the fact that it might get plowed closed.
- Remove snow, ice, and slush from sidewalks, including handicap ramps, within 24 hours after the precipitation has stopped falling. Failing to do so may result in a fine.
- Do not push snow onto the street or onto neighboring properties.
- Pile snow from sidewalks and driveways on lawns, not in the street.
- Clear fire hydrants and stormwater inlets of snow as soon as possible.
- Residents are responsible for clearing snow around mailboxes.
- Basketball hoops are not permitted to be located within the right-ofway and must be removed from the roadway.
- Keep winter driving aids (blanket, shovel, boots, etc.) in the trunk of your car.
- Clear vehicle completely of snow and ice before driving.

## **NEW RESIDENT TO PAP**



All new residents with out-of-state non-commercial driver's licenses must obtain a PA Driver's License within 60 days of establishing Pennsylvania residency.

### GET A PA DRIVER'S LICENSE

To transfer your out-of-state driver's license, you must visit a Pennsylvania driver's license center. At the driver's license center, you will be asked to complete a vision screening test and to provide proof of identity and proof of residency. Finally, once your application has been completed, you will be asked to surrender your out-of-state driver's license.

### REGISTER YOUR VEHICLE IN PENNSYLVANIA

All new residents are required to title and register their vehicle(s) within 20 days of establishing residency in Pennsylvania. To do this, you'll need to bring the following items with you to an authorized agent of the Pennsylvania Department of Transportation. (Most Pennsylvania notaries, dealers and messenger services can help you with this process):

Valid Pennsylvania Identification
Out-of-State Vehicle Title
Proof of PA Insurance
Vehicle Identification Number (VIN) Tracing or Verification
Check or Money Order for fees

Afterwards you will need to take your vehicle to a certified inspection mechanic within 10 days of registering your vehicle in PA. To learn more about registering your out-of-state vehicle in PA, review the Pennsylvania department of Transportation's Motor Vehicle Information for New Residents.

### **HERITAGE COMMITTEE**

### PATAPSCO ROAD

In 1766, the residents of Manheim and Heidelberg Townships petitioned the York County Court to establish a road south of Hanover. The Baltimore County Court had previously laid out a road from the Conewago settlement to Patapsco (aka Baltimore). The route closely follows the present day SR 0094.

This highway was made into a toll road by an act of the Pennsylvania State Legislature, signed by Governor McKean on March 31, 1807. It was built by Edward McCabe and was completed on November 15, 1809. It was about 7 miles in length and extended from Hanover to the Maryland Line. The stones for paving were quarried at various places along the road. They were transported to the roadway from the quarries by horses and wagons. The total cost of the road was \$37,500. The company sold 350 shares of stock at \$100 each. The company paid large dividends to the stockholders from the tolls collected. The toll was from 1.5 cents to 2 cents per mile. The cost of the toll depended on the width of the buggy or wagon wheels (the narrow tires paid more toll).

Two of the road commissioners appointed to direct the construction of the road were from West Manheim Township: Conrad Sherman and George Nace. Two of the managers of the road were from West Manheim Township: Conrad Sherman and Frederick Wentz. There were two toll gates, one near the Maryland line and the other near Hanover. The first toll gate keeper at the Maryland line was John Nace, a grandson of George Nace who was one of the commissioners. The lot for the toll gate house was bought from Bernhart Nace on May 1, 1818, who was a son of George Nace mentioned earlier.

Conrad Sherman and Philp Werking operated taverns along the Baltimore Pike. Based on an 1803 Petition Survey to relocate a portion of the roadway, we know there was 10,712 feet between the two taverns. Deed research has confirmed the location of the Werking's property to be in the 2200 block of the Baltimore Pike. Actual field surveys will be done before this Fall to verify the tavern location on the west side of the road.

## NEW ON-LOT PROCEDURES

### **New On-lot Certification Procedures:**

The Township recently revised the On-lot Subsurface Sewage Disposal Facilities Ordinance. Two important changes for you, the homeowner:

- The septic hauler of your choice will do the inspection/certification of your system. The hauler will provide the inspection report to the Township.
- The Township fee is now \$30.00

As an owner of a home with an on-site septic system you are required to have the system pumped out, inspected and certified every 4 years by a certified sewage hauler. The Department of Environmental Protection requires the system to be inspected for

any cracks or issues which would contaminate the waters of the Commonwealth. The inspection by the hauler will also verify that the system is functioning as designed. The Township will continue to send you a postcard notifying you of the deadline date for the certification of your system.



## WHAT IS A SEEPAGE PITP

### Do you know why you have a Seepage Pit and how to maintain it?



A Seepage Pit, sometimes called a Dry Well, Stormwater Pit, or Infiltration Pit, is a subsurface storage facility that temporarily stores and infiltrates stormwater runoff from the roofs of structures and impervious surfaces. Downspouts connect directly into the Seepage Pit, which may be either an excavated pit filled with uniformly graded aggregate wrapped in geotextile or a prefabricated storage chamber or pipe segment. Seepage Pits discharge the stored runoff via infiltration into the surrounding soils. In the event that the Seepage Pit is overwhelmed in an intense storm event, an overflow mechanism will ensure the additional runoff is safely conveyed downstream.

By capturing runoff at the source, Seepage Pits can dramatically reduce the increased volume of stormwater generated by the roofs of structures. Though roofs are generally not a significant source of runoff pollution, they are still one of the most important sources of new or increased runoff volume from developed areas. By decreasing the volume of stormwater runoff, Seepage Pits can also reduce runoff rate and improve water quality.

Seepage Pits require regular and effective maintenance to ensure prolonged functioning. The following represent the minimum maintenance requirements for Seepage Pits:

- The Seepage Pit should be checked regularly to ensure that no standing water exists in the facility 3 days after the rain event.
- Thorough inspections of the Seepage Pit should occur at least once a year, as well as after every storm exceeding 4 inches in 24 hours.
- Monitor the Seepage Pit facility to ensure that no sediment, grass clippings, leaves, and other similar accumulations occur on top of, and/or within, the piping or pit.
- Regularly clean out gutters and ensure proper connections to facilitate the effectiveness of the Seepage Pit.
- Check cleanout and overflow pipes for clogs, cracks and proper connection.
- Check area surrounding Seepage Pit for signs of malfunction such as erosion, channels, or any damage on the downslope indicating increased runoff or overflow.

## WHEN DIGGING, SAFETY FIRST



# Know what's **BELOW**, **CALL** before you dig.

Safe digging is no accident! Know what's below.

Before your begin digging, state law requires you to call PA One Call at **1.800.242.1776** or **811** at least three days before you dig. All utility companies will be notified of your planned work and will mark the location of any underground lines. Respect the markings and excavate with due care, and be sure to report any and all damage to pipelines, line markers, locator wires, or warning tape to the appropriate utility. If you have a contractor digging at your property, ask the contractor to be extra careful. Make sure there are PA One Call markings and/or flags, and look at the work being done.

#### You should notify PA One Call before you perform any of the following activities:

- Install a fence, mailbox, yard sign, flag pole, or pole for a basketball hoop.
- Install a deck, porch, patio, swimming pool, or garage.
- Install a sprinkler system, pet perimeter fence, septic tank, leach bed, or sand mound.
