PUBLIC WORKS NEWSFALL LIMB PICK UPLEAF COLLECTION

West Manheim Township Public Works Department will be collecting brush and limbs. All items must be curbside by Sunday of designated week to guarantee removal. The west side of the Township will take place on October 11th - 14th and the east side will be October 18th - 21st.

Limbs should be no larger than 3 inches in diameter and brush should be stacked for easy pickup. Absolutely no boards, lumber or construction type debris will be accepted.

The Township reserves the right to refuse excessive amounts of debris. The Township can refuse items that do not meet the requirements and is **NOT** responsible for cleanup. Leaves may be placed curbside for collection starting November 1st. The crews will go through the Township more than once in the event that all leaves are not down and curbside by this date. Leaves must not be in any type of bag or container. Leaf collection is expected to take about 3 - 4 weeks with the last collection day being November 30th, dependent upon the weather conditions.





TAX NEWS

Message from Ruth Neiderer, Tax Collector



Real Estate/Property Taxes are based on your assessed value generated by the York County Assessment Office 717-771-9232. The millage tax rate is determined by the elected officials of each taxing district.

The tax bill is the property owner's responsibility. <u>All bills are mailed to the property owner</u>. I would encourage you to check lender's statements to be sure payments have been disbursed.

The York County and West Manheim Township bills are mailed mid-February and the 2% discount is due mid-April. The South Western School bill is mailed mid-July and the 2% discount is due by the end of September. There is an option to pay the school bill in three installments. The first installment payment must be received by August 31st.

If you have an escrow account which pays your real estate taxes, please contact or forward it to them. If you have applied for a permit due to an improvement to your property, an interim bill is generated. INTERIM bills must be forwarded to your lender for payment. All current year bills must be paid in full by December 31st each year. Personal checks are not accepted after December 15th. Payments can be made by mail or placing in the township drop box or stopping by during office hours. Payments: Credit card and cash (over \$100.00) are not accepted. TOWNSHIP DROPBOX



In an effort to better serve the residents of West Manheim Township a drop box is located on the exterior of the building. The drop box is conveniently located along the front of the building on the west side facing Route 94 (Baltimore Pike). The drop box is labeled *"TOWNSHIP PAYMENT DROP"*. The drop box is secure and available during business and non-business hours.

PRESCRIPTION DRUG TAKE-BACK

West Manheim Township recently joined forces with the York County Solid Waste Authority as a disposal location for over the counter and prescription medicine. Bring your unwanted or expired medicine to the Township Office Monday thru Friday 8am – 4pm for proper disposal.

The following items are *accepted* at this drop off location: prescriptions, prescription solid or liquid medications, prescription patches, prescription ointments, inhalers, over-the-counter medication, vitamins, samples, medications for pets. Please remove or black out personal information on medicine bottles as a precaution. The following items are *not accepted*: thermometers, hydrogen peroxide, aerosol cans, personal care products in the form of nonprescription ointments, liquids or lotions, medications from businesses or clinics, needles (sharps), bloody or infectious waste and hazardous waste.

IMPORTANT REMINDERS

- **DO NOT FLUSH** medications unless instructed to do so.
- Do not give your medication to anyone else or take a prescription not prescribed for you.
- Place sharps (needles, syringes with needles) in a plastic container such as a detergent bottle. Cap or seal the bottle and label it "sharps" and place in the regular garbage, NOT IN YOUR RECYCLE BIN.





ON-LOT PROCEDURES

On-lot Certification Procedures:

The Township revised the On-lot Subsurface Sewage Disposal Facilities Ordinance. Two important changes for you, the homeowner:

- The septic hauler of your choice will do the inspection/certification of your system. The hauler will provide the inspection report to the Township.
- The Township fee is \$30.00

As an owner of a home with an on-site septic system you are required to have the system pumped out, inspected and certified every 4 years by a certified sewage hauler. The Department of Environmental Protection requires the system to be inspected for

any cracks or issues which would contaminate the waters of the Commonwealth. The inspection by the hauler will also verify that the system is functioning as designed. The Township will continue to send you a postcard notifying you of the deadline date for the certification of your system.

WMT IS A MS4 COMMUNITY

You may remember in the Township's Spring Newsletter we discussed the impact of recently being designated as a Small MS4 Community. As a refresher, MS4 stands for **M**unicipal **S**eparate **S**torm **S**ewer **S**ystem and was created in an effort to reduce and eliminate sources of urban and suburban water pollution.

The MS4 Program is mandated by both the Federal (EPA) and State (DEP) government and requires that West Manheim Township actively engage in practices to decrease and eliminate sources of stormwater pollution. Stormwater becomes polluted as it travels across lawns, parking lots, roads, gutters, and ditches. Guided by gravity, stormwater travels downhill picking up speed; and, yard waste, bits of debris, unabsorbed fertilizers, organic wastes, and hazardous chemicals. This contaminated water is not treated, but, conveyed directly into local waterways where it eventually drains to the Susquehanna River, then on to the Chesapeake Bay, and finally the Atlantic Ocean.

An additional source of water pollution caused by stormwater is from the stream channel itself. Urbanized development (roads, residential subdivisions, and non-residential development) increases the amount of surface areas that generate stormwater. As stormwater travels through the Township's conveyance system, it is funneled to tributaries and streams, which then act as a sluice and increase the amount of water in both volume (amount) and velocity (speed). The rushing water then damages and erodes the stream channel by ripping away the side walls and exposing roots. Creeks and streams heavily laden with stormwater are often referred to as "Chocolate Milk" because of its reddish-brown color. The distinctive color is from dirt being eroded

from the stream channel or another source of erosion due to the rate and volume of the water flowing over land. Reducing sediment (fine granules of soil, dirt and other debris) will improve water clarity, while at the same time, reducing the presence of nitrates and phosphates from fertilizers. There are several ways for Township residents to be a part of this effort in the fall months:

- Replace patches of bare soil in lawns and flowerbeds with grass and ground cover plants; this will prevent erosion and sediment-laden water from making its way into the municipal storm sewer system
- Follow all guidelines provided on lawn fertilizer materials
- Keep drains (gutters, roof drains, and inlets) clear of debris. This may also help to prevent instances of localized flooding
- Fall is a great time to inspect any stormwater facilities you may have on our property. i.e. basins, rain gardens, rain barrels, drywells and creek stream and riverside vegetation
- Always pick up and dispose of animal waste appropriately
- Blow grass clippings into your yard and not into the street. This keeps leaf and yard debris out of the street drainage system





STORMWATER ASSESSMENT FEE

West Manheim Township will collect an annual stormwater assessment fee from each property owner within the Township boundaries. The assessment fee will be used towards MS4 requirements such as operation, maintenance, repair, replacement, improvements and for all other expenses related to the MS4/stormwater mandates. Agricultural parcels and single-family residences will be calculated at one ERU (4500 square feet of impervious coverage). Parcels with more impervious area such as nonresidential or commercial parcels will be charged based on their existing impervious coverage. The 2022 invoices will be mailed in January.

WMT SNOW EMERGENCY GUIDELINES

PARKING

When a snow emergency is declared by the Township Board of Supervisors, the following parking regulations must be followed on non-snow emergency Township Roads.

• **Day #1 of snowstorm**: parking is prohibited on the even number side of the street. This will allow for the plowing and salting of the even house numbered side of the road. All vehicles must park in garages, driveways or on the odd house number side of the street.



- Day #2 of snowstorm: After 8:00am on the day following the declaration of a snow emergency, and until the plowing and salting is complete, parking will be prohibited on the odd house numbered side of the road. This will allow for the plowing and salting of the odd house numbered side of the road. All vehicles must park in garages, driveways or on the even house number side of the street.
- Day #3 of snowstorm: The process will repeat with #1, parking prohibited on the evennumbered side of the street.

By following of the above snow emergency regulations, the Township Public Works Department will be able to clear all snow and ice from the roads. Residents are reminded to refrain from shoveling, pushing, throwing, plowing, and blowing snow onto streets. Please refrain from depositing snow onto neighboring properties. Please note, the Ordinance authorizes the West Manheim Township Police Department to have any vehicle parked in violation towed away and stored at any authorized

SIDEWALKS

Every owner, occupant, or tenant is required to remove all snow and/or ice from public sidewalks within 24 hours after the weather event. This includes any snow and/or ice residue from the plow trucks. All snow and/or ice shall be removed to a width of not less than three feet and shall not be placed on any public street or highway. There are no exceptions to this requirement including forecasted warmer temperatures after the weather event. As part of the Quality of Life Ordinance, warnings will not be issued for noncompliance. *Fines of \$50.00 for the first offense will be issued if sidewalks are not cleared*. towing facility at the expense of the owner of said vehicle.

FIRE HYDRENTS

Fire hydrants shall not be covered. The owner, occupant, or tenant is required to remove or any accumulation and/or impediment which would limit access to, from, and/or around all of the fire hydrants which are located on said property, so as to provide immediate access by fire rescue personnel in cases of emergency. In cases involving a storm, fire hydrants shall be cleared of all snow, ice, slush, or any combination thereof within 24 hours following the storm; in any event, any accumulation shall be removed no less than once in every twenty-four-hour period.

EMERGENCY MANAGEMENT AGENCY



The West Manheim Emergency Management Agency works with our municipal government, the West Manheim Police Department and Pleasant Hill Volunteer Fire Company. We keep an updated **Emergency Operations Plan (EOP) that** has been developed and is updated on a yearly cycle. Many community businesses, services, and private individuals have agreed to be part of the emergency plan and have also agreed to provide resources and services in the event they are needed. Snowmobiles, boats, bulldozers, communications equipment; construction equipment, and construction supplies are just some examples of resources. If anyone has resources that could be used in the event of an emergency is interested in being added to our EOP, please contact us at 717-632-

WINTER WEATHER PREPARATION

The National Weather Service refers to winter storms as the "deceptive killers" because most deaths are indirectly related to the storm. People are injured or killed in traffic accidents on icy roads or suffer from hypothermia due to prolonged exposure to the cold. Another major danger associated with winter storms is their ability to knock out heat, power, and communications, sometimes for days at a time. Here are some things you can do to help prepare for winter weather before it strikes.

- Make an emergency plan for you and your family.
- Listen to your radio, television, or NOAA Weather Radio for weather reports and emergency information.
- Make sure your home is well insulated and that you have weather stripping around your doors and windowsills to keep the warm air inside. If you have no heat, close off unneeded rooms, stuff towels or rags in the cracks under doors and cover windows at night.
- Cover pipes with insulation or newspapers and

plastic. Allow faucets to drip a little during cold weather to avoid freezing.

- Learn how to shut off water valves in case of a pipe burst. If the pipes freeze, remove any insulation or layers of newspapers and wrap pipes in rags. Completely open all faucets and pour hot water over the pipes, starting where they were most exposed to the cold (or where the cold was most likely to penetrate).
- Use extreme caution when using alternative heating sources. Refuel kerosene heaters outside and keep them at least three feet from flammable objects. Also, when using kerosene heaters, be sure to maintain ventilation to avoid build-up of toxic fumes. Visit <u>www.befiresafepa.com</u> for more information.
- Wear layers of loose-fitting, lightweight, warm clothing. Several layers of lightweight clothing will keep you warmer than a single heavy coat. Wear gloves (or mittens) and a hat to help prevent loss of body heat.

WINTER WEATHER GLOSSARY

Winter Storm Watch	A winter storm is possible in your area. Tune in to NOAA Weather Radio, commercial radio, or television for more information.	
Winter Storm Warning	A winter storm is occurring or will soon occur in your area.	
Blizzard Warning	Sustained winds or frequent gusts to 35 miles per hour or greater and considerable amounts of falling or blowing snow (reducing visibility to less than a quarter mile) are expected to prevail for a period of three hours or longer.	
Frost/Freeze Warning	Below freezing temperatures are expected.	
Freezing Rain	Rain that freezes when it hits the ground, creating a coating of ice on roads, walkways, trees, and power lines.	
Sleet	Rain that turns to ice pellets before reaching the ground. Sleet also causes moisture on roads to freeze and become slippery.	
Flurries	Light snow falling for short durations. No accumulation or light dusting is all that is expected.	
Showers	Snow falling at varying intensities for brief periods of time. Some accumulation is expected.	
Squalls	Brief, intense snow showers accompanied by strong, gusty winds. Accumulations may be significant.	
Blowing Snow	Wind-driven snow that reduces visibility and causes significant drifting. Blowing snow may be snow that is falling and/or loose snow on the ground picked up by the wind.	
Blizzard	Winds over 35 mph with snow and blowing snow reducing visibility to near zero.	



HERITAGE COMMITTEE

MARY ANN FURNACE TIMELINE-THE EARLY STARTUP YEARS

On March 12, 2021, the Heritage Committee of West Manheim Township retained GeoView, Inc to identify the furnace site along the Black Rock Road using ground penetrating radar. The location remains a mystery, but a possible mill race was discovered and several artifacts were found. A timeline of the furnace startup operations is below:

- September 10,1750 The William Penn Family granted 210.5 acres to Johannes (John) Hunsaker (Hunsinger/Hunsicker/Hunscker) along the West Branch of Codorus Creek. The first survey was performed by William Matthews for the tract called "Friendship".
- **December 13,1759** George Stevenson deputy surveyor resurveyed the Friendship Tract.
- 1761 George Ross and Company partnership formed with George Stevenson, William Thompson and Mark Bird and leased 4 acres from John Hunsinger.
- **1762** Mary Ann Furnace goes into blast along Furnace Creek.
- 1763 George Ross and Company petition the York County Court for a public road from the furnace to the Conewago Settlement (Hanover).
- **1765** Mary Ann Furnace casts the first 10-plate stove in the Colonies (English Stove).

WHEN DIGGING, SAFETY FIRST



Know what's **BELOW**, **CALL** before you dig.

Safe digging is no accident! Know what's below.

Before your begin digging, state law requires you to call PA One Call at **1.800.242.1776** or **811** at least three days before you dig. All utility companies will be notified of your planned work and will mark the location of any underground lines. Respect the markings and excavate with due care, and be sure to report any and all damage to pipelines, line markers, locator wires, or warning tape to the appropriate utility. If you have a contractor digging at your property, ask the contractor to be extra careful. Make sure there are PA One Call markings and/or flags, and look at the work being done.

You should notify PA One Call before you perform any of the following activities:

- Install a fence, mailbox, yard sign, flag pole, or pole for a basketball hoop.
- Install a deck, porch, patio, swimming pool, or garage.
- Install a sprinkler system, pet perimeter fence, septic tank, leach bed, or sand mound.
- Plant trees or bushes.
