# WEST MANHEIM TOWNSHIP BOARD OF SUPERVISORS

# WORK SESSION

Thursday, December 1, 2022 - 7:00 p.m.

Chairman Ault called the Work Session to Order at 7:09 p.m., followed by the Pledge to the Flag and Invocation.

ROLL CALL: Present were Supervisors Ault, Franks, Hartlaub, Rynearson and Wetzel, Township Manager Michael Bowersox, Solicitor David Jones II, from Stock and Leader Attorneys at Law, Township Engineer Cory McCoy from C.S. Davidson, and Township Secretary, Shanna Smale. A quorum was present

ANNOUNCEMENT: Supervisor Ault informed those present that the Board of Supervisors had a brief executive session before the meeting to discuss personnel matters. Supervisor Ault then called Solicitor Dave Jones up to state the agenda would need to be amended under Action Items; J. - to reflect the need to set a date for a public hearing regarding the curative amendment filed by Burkentine & Sons Builders.

PUBLIC COMMENTS: Supervisor Ault asked if anyone present wanted to speak at this time and Andrew Hoffman of 2575 Baltimore Pike came forward to address the board about his concerns regarding the adoption of amendments to the West Manheim Township Zoning Ordinance and Official Township Zoning Map.

Paul Minnich, Attorney from Barley Snyder representing Burkentine & Sons Builders addressed the board regarding Action Item F. - extension request for Burkentine Fields through 5/1/23, asking for a favorable recommendation from the board pertaining to that request.

D. Motion to approve the request to reduce the public improvement financial security for High Point at Rojen Farms: South Section – Phases IIB & IIC

Supervisor Hartlaub made a motion to approve the request to reduce the public improvement financial security for High Point at Rojen Farms: South Section – Phases IIB & IIC to be reduced to two hundred ninety-two thousand, one hundred fifty-four dollars and forty cents (\$292,154.40), seconded by Supervisor Wetzel. **Motion carried.** 

E. Motion to approve Pine Creek Structures Final Land Development Plan (Review time expires 12/15/22)

Supervisor Ault made a motion to conditionally approve Pine Creek Structures Final Land Development Plan (Review time expires 12/15/22). The Indemnification agreement between Pleasant Hill and the developer would need to be signed by the developer and recorded with the final plan. Seconded by Supervisor Franks. **Motion carried.** 

F. Motion to approve the extension request for Burkentine Fields – 310 Unit Preliminary Plan (Review time expires 12/14/22) through 5/31/2023.

Supervisor Ault made a motion that due to Barley Snyder's most recent letter to our solicitor challenging the policy of only one extension request allowed, the solicitor would like to do some research to make sure we are solid on that position and whether we would need to adjust that policy. Burkentine Fields is also the project with the business center in which the public hearing is set for December 20<sup>th</sup>, 2022. Since the township has 45 days after the hearing to write the decision, going through January 31<sup>st</sup>, 2023 would be appropriate. The extension request should be granted the day after the first meeting in February which would be on February 3<sup>rd</sup>, 2022, seconded by Supervisor Rynearson. **Motion carried.**

Karl Reynolds from Reynolds AV, LLC gave a presentation to the board with an overview of what they would propose for the new audio/visual system to be installed in the West Manheim Township board room and to answer the supervisor's questions. Supervisor Hartlaub made a motion to approve the purchase of upgrades to the audio-visual system in the West Manheim Township board room at a cost of \$13,720 for the sound system and \$10,690 for the video system. Total cost is \$24,410 paid with ARPA funds. Work to be performed by Reynolds AV, LLC (CoStars vendor), seconded by Supervisor Rynearson. - 3. Stormwater Assessment Penalties, what to do about them going forward, start thinking about that process.

Jim Myers of Oakwood Drive wanted to ask if the stormwater assessment fee could be combined with any other fees or taxes the residents pay. Solicitor Jones explained that since stormwater is not an assessed tax the township needs to find a way to collect the money.

Supervisor Ault then asked Jennifer Thornton, Township Treasurer to get a breakdown of grant invoices for the Rec Park to find out what was paid for so far by the next meeting on December 20, 2022. Supervisor Ault also stated that the Rec Park needs to clear with the township manager before calling the engineer out for any meetings.
