ORDINANCE #2022-02

AN ORDINANCE CONTROLLING VEHICLES AND TRAFFIC WITHIN WEST MANHEIM TOWNSHIP, YORK COUNTY, PENNSYLVANIA.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of West Manheim Township, York County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same, as follows: That Ordinances #78-2A, #78-2AA, #4-90, #1-97, #4-97, and #1-2002, Ordinance controlling Vehicles and Traffic within West Manheim Township, York County, Pennsylvania are hereby amended, as follows:

ARTICLE I TRAFFIC REGULATIONS, Section 1 - The following stop intersections are hereby added:

Fox Run Road	North	Huntmaster Drive
Huntmaster Drive	East	Fox Run Road

Rec Park	South	St Bartholomew Road
Starlite Drive	South	Dubs Church Road
Wanda Drive	East	Zachary Drive
Wanda Drive	West	Zachary Drive
Water Garden Drive	West	Crystal Clear Drive

ARTICLE II PARKING REGULATIONS, Section 1 - The following areas of parking prohibition at all times are hereby added:

No person shall park a vehicle at any time upon the highway or parts thereof listed described below:

Fox Run Road	West	Huntmaster Dr To Huntmaster Dr
Huntmaster Drive	East	Fox Run Rd to Fox Run Rd

ARTICLE III SPEED LIMITS, Section I – Maximum Speed Limits, as follows:

The Maximum Speed Limit of 25 MPH is hereby established for all of the following roads:

Ruhlman Drive, Vista Loop, Huntmaster Drive.

The Maximum Speed Limit of 15 MPH is hereby established for all of the following roads:




