WEST MANHEIM TOWNSHIP BOARD OF SUPERVISORS YEAR 2023 RE-ORGANIZATION MEETING TUESDAY, JANUARY 3, 2023 6:00 P.M.

The 2023 Reorganizational Meeting of the West Manheim Township Board of Supervisors was held on the above date and time at the Municipal Building at 2412 Baltimore Pike, Hanover, PA.

ELECTION OF TEMPORARY CHAIRMAN

The Meeting was called to Order at 6:10 p.m. by Supervisor Ault, followed by the Pledge to the Flag and the Invocation.

ROLL CALL: Present were Supervisors Ault, Hartlaub, Franks and Wetzel; also present were Sarah Doyle, Solicitor of Stock and Leader, and Township Secretary Shanna Smale. Supervisor Rynearson was present online. Township Solicitor Dave Jones from Stock and Leader and Township Engineer Cory McCoy from C. S. Davidson, Inc., were not present. A quorum was present.

Supervisor Ault then asked for nominations for a temporary chairman and Supervisor Franks nominated Supervisor Ault as temporary chairman, seconded by Supervisor Wetzel. With no other nominations and in a vote of Supervisors Franks, Hartlaub, Rynearson, and Wetzel voting "Yay" and Supervisor Ault abstaining, the Motion carried.

WORK SESSION MEETING

The Work Session of the West Manheim Township Board of Supervisors was called to order by Chairman Ault at 6:24p.m.

CORRESPONDENCE: Chairman Ault noted that the Township received correspondence from Andy Hoffman and Jeffrey Brown for re-appointment to the Planning Commission and Fred Walker for re-appointment to the Rec Park Board. The board also received correspondence from Jeffrey Haines, Fred Walker, Don Whatley and Kelly Gabliks for consideration of appointment to the two open seats on the Planning Commission and Robert Miller and Kelly Gabliks for consideration of appointment to the two open seats on the Zoning Hearing Board. Supervisor Ault also wanted the letter from Jonathan Janney for the Vacancy Board Chairman added to the correspondence.

DISCUSSION ITEMS: None.

SUPERVISORS AND/OR PUBLIC COMMENTS: Chairman Ault asked if anyone from the public wanted to approach the Board, and received no reply.

Chairman Ault then asked if anyone who is a candidate for the open seats on the Planning Commission and Zoning Hearing Board wanted to come forward to address the board. Andy Hoffman came forward to discuss why his sixteen years on the Planning Commission and years of service for the township made him qualified to serve another term. Don Whatley spoke about his background in law enforcement, serving on multiple boards and president of his HOA and living in the township for almost twenty years. Mr. Whatley also stated that he was retired and had plenty of time to dedicate to the township. Finally, Kelly Gabliks talked about how although she is a more recent resident in West Manheim Township, she is always very involved in the community she lives in. She feels it is important to give back to the community and has applied for both the Planning Commission and Zoning Hearing Board. She would be happy to serve on either committee if asked. She has served on many committees and city council and has a legal background as an attorney.
