# (1) Case – VA #03-09-06-2023

Applicant: Whitetail Ridge LLC– Applicant requests a variance from the West Manheim Township Zoning Ordinance, § 270-46 Area Regulations. Applicant seeks a dimensional variance to exceed the maximum lot area permitted for a single-family dwelling.

Location of Applicant's property: Black Rock Road, Parcel #52000-BE-0001, 52000-BE-0011A, 37000-BE-0011 (Portion in West Manheim Township only), West Manheim Township.

The Zoning Hearing Board GRANTED the Variance Request for Whitetail Ridge LLC.

# (2) Case – VA #04-09-07-2023

Applicant: Hanover Commerce, LLC (Taco Bell)—Applicant is requesting two variances from the West Manheim Township Zoning Ordinance: (a) Article XIX Sign Regulations and Requirements § 270-190 Permanent Sign Requirements. Applicant seeks a variance to the maximum number of wall signs permitted. (b) Article XX Parking § 270-197 Schedule of required parking spaces. Applicant seeks a variance to allow for thirty (30) parking spaces where thirty-eight (38) are required.

Location of Applicant's property: 1851 Baltimore Pike Hanover, PA 17331, West Manheim Township.

Vice-Chairman Hawkins made a motion to accept the submitted continuance letter, seconded by David Appleby. **Motion carried** to GRANT the continuance. The hearing will be scheduled on Tuesday, October 24, 2023.
