Applicants seek to use their property in the Commercial-Industrial District for both commercial and residential purposes. Location of Applicant's property: 2901 Baltimore Pike, West Manheim Township, PA 17331

Rob Miller made a motion to **GRANT** the variance from the West Manheim Township Zoning Ordinance: Chapter 270, Article XIX, Sign Regulations and Requirements §270-186.G.(5), to permit an electronic sign within 300 feet of residential use, with the following condition that the electronic sign be turned off between the hours of 9 pm and 6 am daily, seconded by David Appleby. With a three to one vote, **Motion carried**.
