PERMIT LIST

Building permits are needed for the following:

1. Construction or Placement of any structure.

Example: House, Mobile & Modular Homes, Barns, Garages, Car Ports, Utility Sheds, Inground & Above-Ground Pools or Hot Tubs, Decks, Porches, Patios, Walks, Chimneys, Retaining Walls (over 48" high) Electrical, Mechanical, and Plumbing. Also additions to above listings.

- 2. Remodeling, Changing, or Replacement of :
 - a. All structures if any wall, ceiling or floor supports are changed.
 - b. Doors or Windows: new, replacement, or relocation of existing units.
 - c. Basements, Kitchens, Bathrooms, Steps, Decks, etc.
 - d. Driveways & Fences.
 - e. Existing; street curbs & sidewalks.
 - f. Electrical, mechanical and plumbing alterations

3. Driveway permits:

- a. To establish any drive or parking area.
- b. To add, alter, or replace any existing drive or parking area. (Including resurfacing of existing drive and parking area.)

4. Fencing Permits:

a. To install or replace all types of fences or partial fences on property; with the only exception of fencing used for confinement of farm animals.

5. Demolition Permits:

a. Is needed for the removal of all structures and parts of structures, 150 square feet and more.

Permits are not needed for the following:

- a. Painting interior or exterior.
- b. Siding
- c. Roof covering with like materials only. (additions or decking repairs need permits)
- d. Fencing for farm animals, only.
- e. Retaining wall 48" or less.

BUILDERS, DEVELOPERS AND OWNERS

The following is a list of inspections that must be completed on all New Construction or Additions to Existing Structures as required by INTERNATIONAL CODES as indicated below:

Call for an inspection twenty-four hours in advance of required inspection. (Saturdays, Sundays and Holidays are not included in this 24-hour notice)

Call the Township Monday through Friday at (717) 632-0320, between the hours of 8:30 A.M. and 5:00 P.M.

- 1. Site Inspection, Property Corners, Structure Corners, and Driveway at road intersection, all located.
- 2. Inspection of footers prior to pouring of concrete.
- 3. Foundation (Footer drain system, Waterproofing, Plumbing below basement finish floor).
- 4. Framing (with rough-in components that will be covered with building materials).
- 5. Plumbing and pressure test plus mechanicals.
- 6. Insulation
- 7. Storm water system (approved design).
- 8. Public water & sewer.
- 9. Inspection of sidewalks.
- 10. Well site & well permit (site, grouting, final)
- 11. On-site septic certification (by proper authority 717-637-3800 or 717-792-4088)
- 12. Three electrical inspections (by ICC approved 3rd party inspector)
 Same inspector must make all inspections, unless pre-arranged by Township.
- 13. Final For Use and Occupancy Permit
 - * Plumbing
- * Sewer (public & onsite)
- * Electrical
- * Water (public & private)
- * Mechanical
